These reports contain the following information:

### **Student Assessment Data**

- Includes the following three assessments: M-STEP (Michigan Student Test of Educational Progress), MI-Access (Alternate Assessment), and College Board SAT
- Presents assessment information for English language arts and mathematics for grades 3 to 8 and 11, and MI-Access science for grades 4, 7, and 11, compared to state averages for all students and subgroups.

### **School Accountability Data**

- Includes information on schools' performance on various measures such as student proficiency and growth on state assessments, graduation, and attendance rates. Performance is measured on 0-100 index scales.
- Reports schools identified under three federally required categories for further support: Comprehensive Support and Improvement, Targeted Support and Improvement, and Additional Targeted Support

- Identifies the number and percentage of inexperienced teachers, principals, and other school leaders
- Reports teachers who are teaching with emergency or provisional credentials
- Includes teachers who are not teaching in the subject or field for which they are certified

• Provides state results of the national assessment in mathematics and reading every other year in grades 4 and 8

Creekside	No Label	Our School Improvement Plan focuses on increasing student access to academic instruction by supporting healthy emotional regulation. The staff at Creekside School utilize Professional Learning Communities to learn, strengthen, and reflect on system-wide responses to students' emotional regulation needs. Restorative Practices, Crisis Prevention Intervention (CPI), PREPaRE, Social Skills Improvement System (SSIS), Positive Behavior Interventions and Supports (PBIS) and Applied Educational Neuroscience (AEN) provide a foundation for and are examples of supports embedded in daily programming to increase student access to academic instruction.
Life Skills Center	No Label	Our school improvement plan currently consists of goals related to polishing our strong system for data-based decision-making that will lead to student growth for all students. As part of this work, teachers are involved in professional learning communities that address

		assessments being implemented in our program and evaluate curriculum implementation and instructional practice.
New Horizons	No Label	Our district school improvement plan currently consists of goals for establishing a strong system for data-based decision-making that will lead to student growth in math and literacy. As part of this work, teachers are involved in professional learning communities that address effective assessment of students' skills, curriculum alignment to state standards, and effective instructional practices. They participate in data review meetings three times a year where student data related to math and literacy is reviewed, and action plans are developed based on individual student needs.

Over the past few school years, all departments across North Ed have embarked on a renewed mission by implementing our strategic plan, SAIL. We are now updating our strategic plan to SAIL 2.0 (Serving, Achieving, Inspiring, Learning).
